

Terms and Conditions



Definitions

The Make-Up Artist: Sarah Waters

The Client: The recipient of the service and name(s) listed on the booking form.

The Event: Relates in principle to the date whereby the event (i.e wedding) takes place.

The Party: Additional members of the bridal party or group booking.

The Fee: The amount payable by the Client to the Make-Up Artist for the services agreed on the booking form.

Securing Services

The booking of the Event is only reserved once the Client has paid the non-refundable deposit to the Make-Up Artist.

A deposit of £50 is required to secure a Wedding booking. For Special Occasion Make-Up, Make-Up Lessons, and Facials, a £10 non-refundable deposit to the Make-Up Artist will secure the Event.

Please note that arranging a trial does not reserve the Make-Up Artists services for the Event. This will only be secured as per the above.

Additional Party Trials for a wedding Event must be paid for on the day of the trial.

Payment

Payments must be made via bank transfer or paid in cash. Bank details available on request.

Payment for Wedding Bookings:

A non-refundable deposit of £50 is to be paid by the Client and will be deducted from the total agreed Fee. This amount will be deducted for the total agreed Fee.

The Fee is to be paid in full by the Client one month (28 days) prior to the event taking place.

Failure to make payment within the stated time frame will result in the Event being cancelled by the Make-Up Artist.

Payment for Special Occasion Make-Up, Make-Up Lessons and Facials:

A non-refundable deposit of £10 is to be paid by the Client and will be deducted from the total agreed Fee.

The Fee is to be paid in full by the Client on the day of the Event.

Booking/ Changes

At the time of booking the Event, the Party numbers will be confirmed by the Client. Any changes made by the Client before the Event must be agreed to in writing by the Make-Up Artist.

Travel Expenses

The Client will cover any necessary travel expenses incurred but the Make-Up Artist for Events for venues or addresses over 25miles from LD15PU; at a rate of 50p per mile (both ways); total travel fee to be agreed at the time of the booking.

Responsibility of the Client

The Client shall inform the Make-Up Artist of any issues that may affect the use of any equipment or products. This includes, but is not limited to sensitivities, allergies and medical conditions. The Make-Up Artist cannot be held responsible for any losses or damage incurred as a result of the Client's failure to disclose any known conditions.

Cancellations

The Client can cancel the Event by informing the Make-Up Artist in writing.

Cancellation by the Client within one month (28 days) of the Event will result in the full Fee payable by the Client.

The Make-Up Artist will be under no obligation to refund any monies paid up until the point of cancellation.

In the unlikely event of the Make-Up Artist cancelling due to unforeseen circumstances, where possible a replacement Make-Up Artist will be offered. If an alternative cannot be provided then a full refund will be given to the Client. No further compensation will be offered.

Photography

The Client agrees that the Make-Up Artist may use any photography taken by the Make-Up Artist for publicity purposes which include, but are not limited to the Make-Up Artist's social media pages and website. The Client must notify the Make-Up Artist in writing, prior to the Event, if they object to the use of photography.
